2. Set-up time for your vendor table in a designated area must be completed between 9:00 AM-11:30 AM
3. Vendors will be responsible for paying their own sales tax.
4. No music allowed in the vendor area. The Black Art Brunch will provide all entertainment.
5. No sharing of vendor tables, unless preauthorize by the Black Art Brunch Committee.
6. Any vendor-provided banners must be neatly displayed and freestanding confined to the assigned area. **Vendors are responsible for properly displaying a listing of products sold and the corresponding prices.**
7. Vendors are responsible for the decoration of their own tables. Vendors must bring their decorations, tablecloths, and signs. You may bring your own chairs and additional tables if needed. **Vendors are fully responsible for any damages to the area or table.**
8. Violators of the rules or illegal vendors will be reposted to BSO / City of Pompano Beach Police Department.
